Considerations when choosing a probono opportunity

- What do you like doing?
- What special skills or language fluencies do you have, or want to gain?
- How much time do you have to spend on your commitment?
- Do you have special needs that may need to be accommodated?

Varying ranges of commitment ~ depends on your schedule and interest

- Intake/triage
- Limited scope
 - Lawyer and client agree that the lawyer will handle some parts of the case and the client will handle others
- Full scope
- · Legal research
 - Lawyer is hired to provide legal services on all aspects of a case from start to finish

Pro bono opportunities range from limited, discrete tasks...

- Active listening during intake
- · Explaining legal procedure
- Strategizing and explaining options
- · Referring to help for next steps
- Assisting with forms or tech
- Interpreting / translating

... to full-scope representation

- Representing client in litigation (alone or part of team)
- Negotiating pre-litigation
- Contracts/transactional
- · Assisting with forms or tech
- Interpreting/translating
